Univ.-Prof. Dr. George Karamanolis, Privatdoz. MA

Univ.-Prof. Dr. George Karamanolis, Privatdoz. MA am Professor of Philosophy in the Department of Philosophy at the University of Vienna working primarily on ancient philosophy while maintaining research interests in Byzantine and Renaissance philosophy. My publications include the monographs, *Plato and Aristotle in Agreement? Platonists on Aristotle from Antiochus to Porphyry*, Oxford 2006 (revised paperback 2013), *The Philosophy of Early Christianity*, London/Durham 2013 (revised 2nd edition London 2021) and the edited volumes *Studies on Porphyry*, London 2007 (with Anne Sheppard), *The Aporetic Tradition in Ancient Philosophy*, Cambridge 2018 (with Vasilis Politis, paperback 2019), *Introduction to Ancient Philosophy 2017* (Crete University Press, in Modern Greek), *Pseudo-Aristotle On the Cosmos: A Commentary*, Cambridge 2020 (with Pavel Gregorić, paperback 2022). My main research interests lie in ancient Platonism and Aristotelianism and the philosophy of late antiquity, which includes early Christian philosophy. I am currently working on Aristotle's ethics, on Cicero's ethics, on Porphyry, and on various aspects of early Christian Philosophy. I am leading an FWF project aiming at a new edition with commentary of the Aristotelian *Magna Moralia*.

Mag. Michael Kramer, PhD

*Faculty of Catholic Theology
Department of Islamic-Theological Studies*

As an Austrian jurist and political scientist, my research focuses on the diverse living environments of Muslims through an interdisciplinary lens, spanning law, political science, sociology, and religious education. By employing multidisciplinary approaches, I analyse amongst others the complex factors shaping the relationship between the state and Islam, with a particular emphasis on the Islamic Religious Community in Austria (IGGÖ), its members, and the broader non-organized Muslim community. My work aims to conceptualize a socially integrative and pluralistic "Austrian Islam"—an expression of Islam that operates within Austria's legal and political framework while safeguarding human rights, minority protections, civil society, and social cohesion against Islamist threats and ideological challenges, including

opposition to civic education. My academic contributions span Islamic dispute resolution, peacebuilding, European-Islamic theology, Islamic and interreligious education, as well as broader inquiries into religious and cultural dynamics in schools, and manifestations of antisemitism and antizionism in Austrian mosque communities.

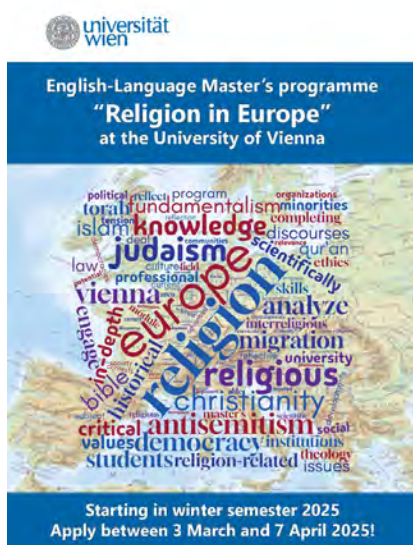
CONGRATULATIONS!

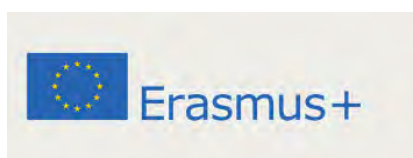


Discover the new Master's programme "Religion in Europe" at the University of Vienna:

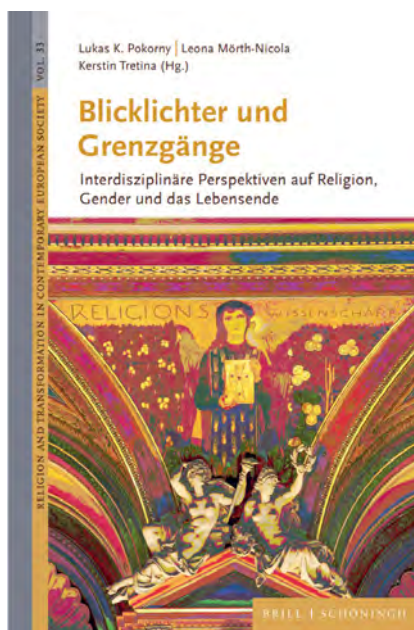
Erasmus+ is the European Union's flagship program for education, training, youth, and sport. It aims to promote international cooperation, cultural exchange, and academic mobility.

JRAT 10 (2/2024): Bible and Philosophy, edited by **Kurt Appel, and Esther Heinrich**

The present volume 'Bible and Philosophy' subjects various biblical texts and motifs, including the fall of man, Noah's ark, Jacob's ladder, the Song of Songs, the resurrection of Jesus, the problem of human and divine violence, the singularity and recognisability of God and the Christian understanding of baptism to philosophical reflection. It is based on an understanding of philosophy that does not renounce



the question of truth, but does not reduce truth to that which is quantifiable and measurable either. Biblical hermeneutics which closely links the question of truth to the question of the meaning of human existence and the question of justice is given particular consideration.

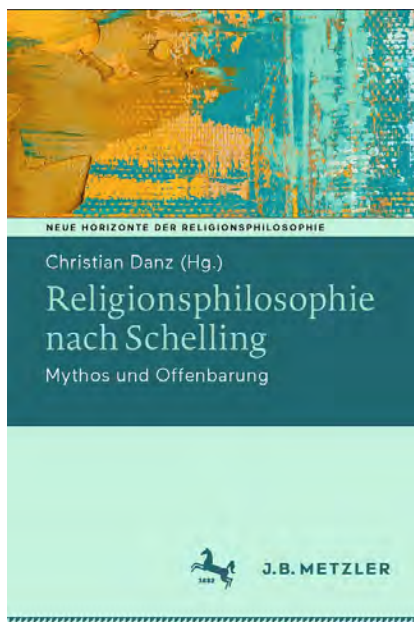

Christoph Augustynowicz, Martina Fuchs, and Florian-Jan Ostrowski (eds.): Alltag – Erinnerung – Aufarbeitung an der Universität Wien. Historische Wissenschaften in Austrofascismus, Nationalsozialismus und Nachkriegszeit. Vienna: Vienna University Press, V&R 2025.

Remembering is an active, collaborative process to slow down collective forgetting. The history departments of the Faculty of Historical and Cultural Studies at the University of Vienna are increasingly dealing with their past in the years of Austrofascism, National Socialism and the post-war period. Many members of the University of Vienna were victims, but many more were enablers and accomplices of National Socialist ideology. Individual results of this reappraisal are presented in this volume. In addition to fundamental remarks on the subject of history at the University of Vienna, on the development of the discipline between the 1930s and 1960s and on everyday university life and the library system, four lecturers are presented under the heading “Between the roles of victim and perpetrator”. Another article commemorates a medievalist from Graz who studied in Vienna and perished in the Theresienstadt ghetto in 1942.

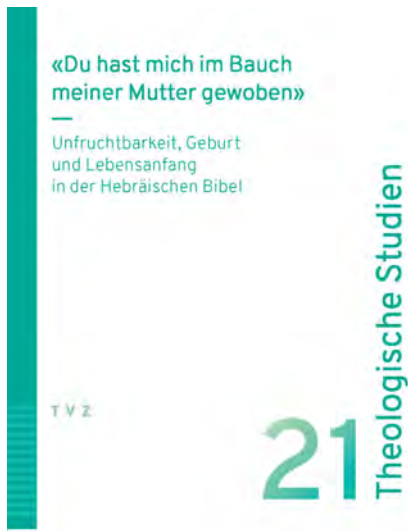
Christian Danz (ed.): Religionsphilosophie nach Schelling. Mythos und Offenbarung. Heidelberg/Berlin: Metzler 2024.

F.W.J. Schelling (1775–1854) is one of the most important representatives of the so-called German Idealism. His work is fundamental to the emergence of modern philosophy of religion, which established itself as an independent academic discipline in the 1790s following Immanuel Kant's critique of reason. This volume presents Schelling's philosophy of religion for the first time from hermeneutic and developmental perspectives. In this way, the contributions of the volume not only introduce the complex history of the emergence of the philosophy of religion against the backdrop of Enlightenment debates but also reconstruct the development of Schelling's understanding of religion throughout his works, up to his later writings, and explore the significance of his theory of religion for contemporary debates in philosophy and theology.

Unfruchtbarkeit, Geburt und Lebensanfang in der Hebräischen Bibel. Zürich: Theologischer Verlag Zürich 2025.

Texts of the Hebrew Bible, the Old Testament, show how people over 2000 years ago processed experiences related to the beginning of life, fertility, and birth, along with the hopes, expectations, and fears associated with them. They describe – not in a defining or normative way, but narratively and poetically – pregnancy and birth as an interplay between humans and God. They remind us that at the beginning of life, much is beyond human control and that blessings are not available on demand. Marianne Grohmann traces these biblical concepts and explores their potential for addressing current existential questions related to the beginning of life.

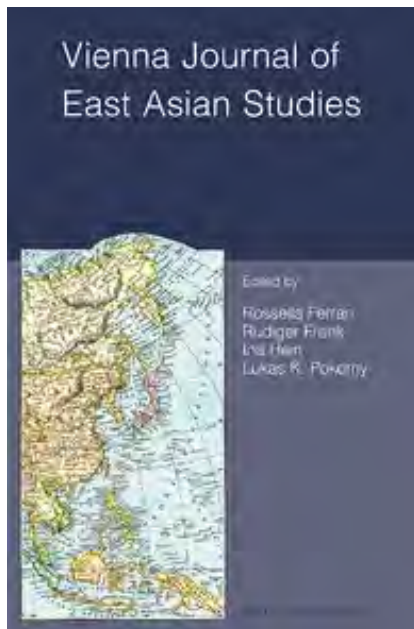

Lukas K. Pokorny (ed.): Religion in Austria 9. Wien: Praesens 2024.

In the Religious Studies book series “Religion in Austria”, the religious panorama of Austria is being successively developed within the framework of special studies. In addition to a large number of articles and reviews, the newly published Volume 9 also contains bibliographies of all research papers on religion in Austria from 2023 as well as a list of all diploma and master's theses and dissertations in Religious Studies completed during this period. The ninth volume of the book series places a special focus on Tibetan, Chinese and Taiwanese Buddhism. The other articles range from a study on the professionalization of “energy healing” and the history of the Association of Evangelical Churches in Austria to a historical review of the history and role of the Faculty of Protestant Theology with regard to anti-Semitism and National Socialism from 1938 onwards.

The Vienna Journal of East Asian Studies (VEAS) is a double-blind, peer-reviewed open access journal. It publishes original research in the field of East Asian Studies, including Greater China, the Korean Peninsula, Japan and Vietnam. This special issue is the third collection resulting from a collaborative research project on the Euro-American esoteric appropriation of East Asia.

Jan-Heiner Tück: Minima theologica. Spuren des Heiligen heute. Freiburg im Br.: Herder 2025.

Even in the accelerated lifeworlds (Lebenswelten) of today, there are traces of the sacred: Moments in which the secular horizon points beyond itself, experiences of human self-transcendence that make it clear that what is, is not everything. In art, literature, music and architecture, we can experience a glimpse of abundance.

In order to sharpen our sense of the cultural presence of the sacred, the miniatures in this book trace scattered traces of the sacred. These are sketches of an experimental theology that bring together everyday observations and fragments of reflection, as well as attempts to interpret what has been read, seen and heard. The aim is to allow the whole to appear in the fragment.

Jakob Deibl: *Aufbrechen, um zu bleiben. Freiheit im Widerstreit mit sich bei Hölderlin, Hegel und Beethoven*, in: Violetta L. Waibel, Jörg Robert, Martin Vöhler (eds.): „... die Freiheit aufzubrechen“. *Hölderlin Hegel Beethoven* (Hölderlin-Forschungen 5), Paderborn: BRILL/Fink 2025, pp. 109–135.

The article is dedicated to the dialectical tension between departure and staying in the works of Beethoven, Hegel, and Hölderlin, and poses the question of whether this tension can offer a possible access to their work. The article first references Beethoven's *Fidelio* and sees the tension between departure and staying expressed through the pathos of freedom and through fidelity. It then turns to Hegel's interpretation of the Abraham narrative in his early writings, interpreting Abraham as a paradigmatic figure of departure. Finally, Hölderlin's poems *Brod und Wein* and *Am Quell der Donau ...* are examined. The tension between departure and staying not only provides access to these texts but also to Hölderlin's self-conception as a poet.

Regina Polak: *Interreligiöse Beziehungen und Interkultureller Dialog*, in: Gmainer-Pranzl, F., Gruber et al. (eds.): *Handbuch Interkulturelle Theologie*. Berlin/Heidelberg: J.B. Metzler 2024.

Since the turn of the millennium at the latest, interdisciplinary research on interreligious relations has focused on interreligious dialog as a programmatic concept and normative-ethical value. The fact that this is always an intercultural dialog as well remains comparatively overlooked. Conversely, religion is subsumed or largely ignored in research on intercultural dialog as part of culture. The article offers an overview of this historical novelty and outlines prospects for what intercultural theology as a translation and bridging discipline can contribute in the future to in-depth interdisciplinary research into interreligious relations and intercultural dialog.

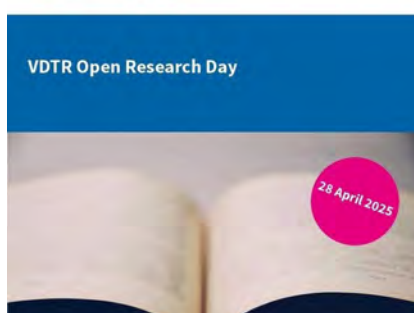
Eduard Prenga: *Inversione fenomenologica: "Dalla cosa stessa!" La Rivelazione come evento di linguaggio, fenomeno della reciprocità trinitaria*, in: Tommaso Bertolasi, Antonio Bergamo, Giuseppe Pintus (eds.): *Fenomenologia e Rivelazione*, Bd. 8 des Dizionario dinamico di ontologia trinitaria. Rome: Città Nuova 2025, pp. 131-157.

The authors of this volume address two fundamental questions: What is the horizon within which a revelation is given—if such a horizon exists? And what do we primarily mean when we speak of revelation? Both questions arise from the awareness of the conceptual and epistemological complexity of "revelation." This concept has existed since the beginnings of theological reflection. Throughout the history of ideas, it has repeatedly been the subject of opposing interpretations. The authors, who come from both philosophical and theological backgrounds, attempt to approach the topic with their respective methodologies. E. Prenga offers a comprehensive interpretative key. He engages with Feuerbach's critique of religion and the accusation of projection in dialogue with its interpretation by Joachim Negel. For Prenga, Husserl's phenomenological key is fundamental: "To the things themselves!" However, he believes that theology cannot adopt this principle without a "process of inversion." Therefore, Prenga formulates the thesis of a "phenomenological inversion" in the theological realm, particularly concerning the question of revelation. A phenomenological approach to the question of revelation only makes sense if we start "From the thing itself!"—that is, from the one who un-veils himself of his own accord.

Anna Hager: FWF Elise Richter Project: Exploring the Core Through the Margins

This research project funded by the FWF (Elise Richter fellowship) will investigate two separate topics that have so far been largely neglected by prevalent scholarship: firstly, a Christian community in the Middle East and secondly, Islamic attitudes toward local Middle Eastern Christians.

This project will focus initially on the rebuilding of the Syriac Orthodox community in Lebanon (1918–1982). This community, historically called “Jacobite” or “monophysite”, holds a special status in the context of Middle Eastern Christianity, on the one hand, as a group which is especially at risk and, on the other hand, as preservers of Aramaic, the language of Jesus Christ. To this day, the Syriac Orthodox Church continues to use the Syriac Aramaic language in its liturgy. Up until the First World War, they mostly lived in what is today Southeastern Turkey (then part of the Ottoman Empire), where they were targeted during the Armenian genocide. Yet it is not widely known that many of those who survived managed to successfully rebuild their communities in the new nation-states of the Middle East, among them Lebanon. However, at the same time, the Syriac Orthodox struggled in Lebanon to be fully recognized as part of the Lebanese nation.

This project will then go on to focus on another unknown and neglected topic as regards Islam:

Islamist attitudes towards Middle Eastern Christians over the last decades. A key question, raised not only in a strictly scientific context, is whether Islamist parties and movements moderate their ideological stance, especially when they strive to establish an “Islamic” system, and under what circumstances they may do this. In this regard, their attitude towards the Christian communities of their countries, whether that country is Egypt, Lebanon, or Jordan, are salient because Christians are useful political tools, allowing Islamist figures to appear as moderate and serious political actors (or not). The focus on such not unreservedly Islamic topics gives us a better understanding of core elements of the Islamic heritage and the establishment of an ideal Islamic society.

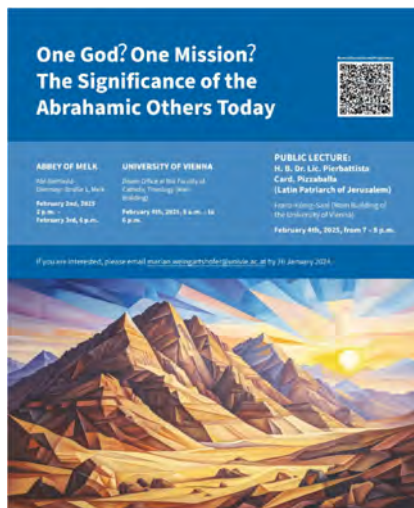

Report on the International Conference "One God? One Mission? The Significance of the Abrahamic Others Today" (Part 1: Between Christianity and Islam)

From February 2 to 4, 2025, the international conference *One God? One Mission? The Significance of the Abrahamic Others Today* took place at Melk Abbey and the University of Vienna. The conference was organized by the Research Center Religion and Transformation in Contemporary Society (RaT) at the University of Vienna in cooperation with the Université de Montréal (Canada) and the Sophia University Institute (Italy). The organizers, **Kurt Appel**, **Piero Coda**, **Aysun Yaşar**, **Patrice Brodeur**, and **Eduard Prenga**, worked for nearly two years on the organization of the conference. For the on-site implementation, they were supported by the entire team of the RaT Center, particularly by Jakob Deibl, Noemi Call, and Marian Weingartshofer.

Thematically, the question of the revelation of the one God as a connecting fundamental question of the three Abrahamic religions was placed at the center. In the reflective engagement with this question, the

speakers particularly focused on the current global context in which humanity finds itself. There was also the opportunity for immediate discussion following the respective lectures. Renowned scholars from around the world were invited as speakers, including **Susannah Heschel** (USA), **Mohammed Ali Shomali** (Iran), **Patriarch Pierbattista Pizzaballa** (Jerusalem), as well as experts from Canada, the Middle East, and Europe, among whom professors from the Faculty of Catholic Theology at the University of Vienna (**Regina Polak**, **Kurt Appel**, **Jakob Deibl**) made their outstanding contributions. The conference formed the first part of a larger event and focused particularly—but not exclusively—on the relationship between Christianity and Islam, highlighting the mutual significance of the respective Other. The concluding lectures built a bridge to **the second part of the event, which is expected to take place in 2027**. The main focus of the second part will be the respective engagement with the relationship between 1) Judaism and Christianity; 2) Christianity and Islam; 3) Judaism and Islam; and 4) Judaism-Christianity-Islam. Through this reflection, perspectives for a renewed and deepened humanity are also to be offered.
